- Allows companies to establish trade routes
- Provides the ability to determine which FTAs are available based on the participating countries
- Ability to search by the following attributes:
  - › Importing Country (TA Country)
  - › Country of Export (Participating Countries)
  - › Tariff Classification
- Search criteria is pulled from existing Trade Programs data and compares HS codes and countries to display applicable FTAs
- Search results allow for:
  - › General FTA information with Reference Link
  - › On demand Rules of Origin search based on FTA Country and HS number
